

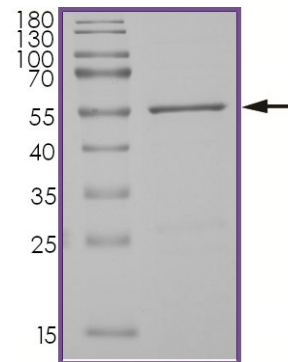

Store at -20°C. To avoid repeated handling and multiple freeze/thaw cycles aliquot diluted product into smaller quantities.
