### Product Description

Recombinant 2019-nCoV Spike protein S1 (16-685) was expressed in CHO cells using a C-terminal His tag. The gene accession number is [MN908947](#).

### Formulation

Recombinant protein stored in 50mM sodium phosphate, pH 7.5, 300mM NaCl, 150mM imidazole.

### Storage and Stability

Store product at  $-70^{\circ}\text{C}$ . For optimal storage, aliquot target into smaller quantities after centrifugation and store at recommended temperature. For most favorable performance, avoid repeated handling and multiple freeze/thaw cycles.

### Scientific Background

The severe acute respiratory syndrome related novel coronavirus SARS-CoV-2 has caused the pandemic of the respiratory diseases (COVID-19) around the world in 2020 (1). The spike glycoprotein (S) of coronavirus belongs to the type I transmembrane protein containing two subunits, S1 and S2 (2), which is also known to be the key component to bind with host cells through the interaction with angiotensin-converting enzyme 2 (ACE2) (3). A receptor binding domain (RBD) of S1 can recognize the cell surface receptor and the mutation of RBD could cause higher motility rate (3).

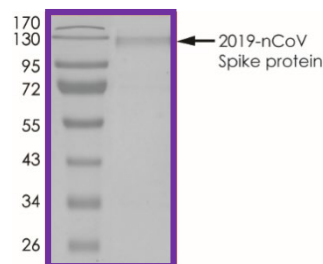

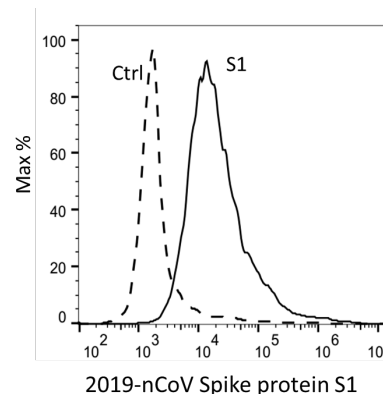
### Purity

The purity of 2019-nCoV Spike protein S1 was determined to be **>90%** by densitometry. Observed MW **~125 kDa**. Calculated MW **~76 kDa**.

### Activity



FACS assay showed 2019-nCoV Spike protein S1 can bind to ACE2 overexpressing cells. ACE2 overexpressing cells were stained with 2019-nCoV Spike protein S1, followed by anti-2019CoV Spike Protein antibody (C19S1-61H) and fluorescence-conjugated secondary antibody.
